First, I would like to congratulate you on your election as President and assure you of our delegation's full support.

Malta aligns itself with the European Union's statement but would like to add a few remarks in our national capacity.

The world faces a complex and challenging environment, aptly described as a "cauldron of crises" by the Secretary General of the United Nations, Antonio Guterres. To address this, we must prioritize disarmament, non-proliferation, and arms control, avoiding any **nuclear arms race**.

The Treaty on the Prohibition of Nuclear Weapons **(TPNW)**, to which Malta is an original signatory, holds renewed importance, and we urge all nations to join.

Diplomacy and multilateralism remain our best tools to navigate these challenges. As a current **Member of the United Nations Security Council**, Malta is committed to upholding the rules-based international order.

Malta strongly calls on the DPRK to return to the full compliance with the NPT, the IAEA's Comprehensive Safeguards Agreement, and the Additional Protocol, and to sign and ratify the Comprehensive Nuclear-Test-Ban Treaty. Malta supports all diplomatic efforts aimed at pursuing the complete, verifiable, and irreversible denuclearisation of the Korean peninsula.
