

## 向国际原子能机构交款状况的财务报表

### 总干事的报告

1. 《国际原子能机构 2021 年财务报告》<sup>2</sup> 报告了截至 2021 年底向国际原子能机构财政交款的状况，而 2022/Note 32 号和 2022/Note 51 号“秘书处的说明”报告了本年度财政交款的状况。为便于大会审议，对这些交款报表状况作了更新，以反映截至 2022 年 9 月 23 日的交款状况，有关交款报表复载于以下附件：
