SCALE OF MEMBERS' CONTRIBUTIONS FOR 1962

Memorandum by the Director General

1. The Director General submits herewith, for the consideration of the General Conference, the proposed scale of assessment for 1962.
2. The scale has been calculated in accordance with the recommendation made by the General Conference at its second regular session that:
"commencing with the scale of assessment for 1960, any scale of assessment which is approved in advance by the General Conference should be based on the scale adopted by the United Nations for the preceding calendar year and should be final and not subject to any retroactive adjustment." [1]
3. On 10 December 1958, the General Assembly of the United Nations approved a three year scale of assessment for 1959, 1960 and 1961, and it was on this scale that the Agency's scales for 1960 and 1961 were based [2].
4. There has been no change in the United Nations scale as between 1960 and 1961, and accordingly the Director General submits, within the framework of the draft resolution set forth below, a proposed scale for 1962 which includes all States that were Members of the Agency as at 31 August 1961. An explanation of the numerical data used in calculating the scale is given in the Annex to the present document. The second paragraph of the resolution sets out a suggested procedure for calculating the contributions of any State that becomes a Member of the Agency after the scale for 1962 has been adopted.

The General Conference,

1. Decides that the scale of assessment for Members' contributions to the Agency's Regular Budget for the financial year 1962 shall be as follows:

2. Decides further that any State that becomes a Member of the Agency during the remainder of 1961 or in 1962 shall be assessed as appropriate for contributions to the Agency's Regular Budget for those years, and for its advance to the Working Capital Fund, by applying to its United Nations percentage the same coefficient as was applied in the case of Member States whose rates of assessment are included in the scales of assessment for 1961 and 1962.

B. Method for calculating the coefficient 0.921

1. The total United Nations assessments for 1959-61 for Members of the Agency who are also Members of the United Nations is 99.23 per cent, while the total assessments recommended by the United Nations for Agency Members who are not Members of the United Nations is 6.79 per cent, a grand total of 106.02 per cent (see columns 2 and 3 of section A above).

2. It is therefore necessary to find a coefficient by which to multiply the United Nations assessments of the Agency's Members so as to reduce the total to 100.00 per cent. In arriving at this coefficient the following considerations have been taken into account:

- (a) The percentages of the following Member States are fixed at a minimum of 0.04 per cent in both the Agency and the United Nations scales:

Albania
Cambodia
Haiti
Holy See
Honduras
Iceland
Mali
Monaco
Nicaragua
Paraguay

giving a total of 0.40 per cent; and

- (b) The maximum contribution of the United States of America in the Agency's scale for 1961 was set at 32.43 per cent. In accordance with paragraph (b) of resolution GC(III)/RES/50, the coefficient has not been applied to the United Nations percentage of the highest contributor. However, its fixed percentage of 32.43 per cent has been reduced in the 1962 Agency scale by applying to it a proportionate share in the percentage of the new Member States which have joined the Agency. This reduction has not resulted in any increase in the percentages of other Members.

3. It will be noticed that the new percentage of the highest contributor is fixed at 32.27 per cent. In calculating the scale, care has been taken to ensure that in no case does the per capita contribution of any Member exceed that of the highest contributor.
