ADOPTION OF THE AGENDA AND ALLOCATION OF ITEMS FOR INITIAL DISCUSSION

## Report by the General Committee under Rule 42 of the Rules of Procedure

- 1. At its fourteenth meeting on 21 September 1966, the General Committee considered the provisional agenda for the current session  $\frac{1}{2}$ .
- 2. In the light of the communication by the Director General in document GC(X)/335/Add.1, the Committee came to the conclusion that it would be unnecessary for the Conference to devote time at the current session to discussion of omergency assistance in the event of nuclear radiation accidents. It accordingly recommends that item 17 of the provisional agenda should not be included in the agenda.
- 3. The Committee was informed that there would be no business for the Conference under item 20 of the provisional agenda Elections to the Agency's Staff Pension Committee, and it accordingly recommends that this item also should be omitted from the agenda.
- 4. The Committee recommends that the remaining items of the provisional agenda should be included in the agenda.
- 5. With regard to the allocation of agenda items for initial discussion, the Committee is in agreement with the suggestions made in document GC(X)/326 and accordingly recommends that the items be so allocated for initial discussion.
- 6. The recommendations thus made by the Committee are summarized overleaf.
