ADOPTION OF THE AGENDA AND ALLOCATION OF ITEMS FOR INITIAL DISCUSSION

Report by the General Committee under Rule 42 of the Rules of Procedure

1. At its eighteenth meeting on 22 September 1970, the General Committee considered the provisional agenda for the current session which is set forth in document GC(XIV)/429.

2. The Committee decided to recommend that all the items of the provisional agenda, except item 6 - Application for membership of the Agency - under which there was no business for the Conference to transact, should be included in the agenda for the session.
