ADOPTION OF THE AGENDA AND ALLOCATION CF ITEMS FOR INITIAL DISCUSSION

Report by the General Committee under Rule 42 of the Rules of Procedure

1. At its nineteenth meeting on 21 September 1971, the General Committee considered the provisional agenda for the current session which is set forth in document GC(XV)/454 and Mod.1.

2.
