Memorandum by the Director General

1. The table overleaf is intended to notify delegates, at the opening of the General Conference's session, of the pledges of voluntary contributions to the General Fund for 1973 that Members of the Agency have made by 5 p.m. on 22 September 1972.
2. It is foreseen that the Conference will consider the matter of voluntary contributions to the General Fund in a plenary meeting at which the President will invite attention to the list of contributions pledged in advance. Revisions of the present memorandum therefore will be issued as the session proceeds for the purpose of keeping the Conference informed of the growth in the total value of the pledges that Members have made.
