APPLICATIONS FOR MEMBERSHIP OF THE AGENCY

Application by Mongolia

Recommendation by the Board of Governors

1. On 27 August 1973 the following telegram addressed to the Director General by the Minister for Foreign Affairs of Mongolia was communicated to the Board:

"I HAVE THE HONOUR INFORM YOU HEREBY THAT GOVERNMENT OF MONGOLIAN PEOPLE'S REPUBLIC HAVE DECIDED TO BECOME MEMBER OF IAEA. I WISH TO ASSURE YOU THAT IN ACCORDANCE WITH PURPOSES AND PRINCIPLES OF CHARTER OF UNITED NATIONS MONGOLIAN PEOPLE'S REPUBLIC WILL CO-OPERATE FRUITFULLY WITH IAEA AND WILL CARRY OUT OBLIGATIONS LAID DOWN IN ITS CONSTITUTION."

2. On 14 September the Board considered this application for membership of the Agency in the light of Article IV.B of the Statute, and determined that Mongolia was able and willing to carry out the obligations of membership of the Agency and to act in accordance with the purposes and principles of the Charter of the United Nations. The Board accordingly recommends the Conference to approve Mongolia for membership of the Agency, and submits the draft resolution overleaf for the consideration of the Conference.

## APPLICATION BY MONGOLIA FOR MEMBERSHIP OF THE AGENCY

## The General Conference,

(a) <u>Having received</u> the recommendation of the Board of Governors that Mongolia should be approved for membership of the Agency,  $\frac{1}{2}$  and

(b) <u>Having considered</u> the application of Mongolia for membership in the light of Article IV.B of the Statute,

1. Approves Mongolia for membership of the Agency; and

2. <u>Determines</u>, pursuant to Financial Regulation  $6.08^{2/}$ , that in the event of Mongolia becoming a Member of the Agency during the remainder of 1973 or in 1974, it shall be assessed as appropriate:

- (a) For an advance or advances to the Working Capital Fund, in accordance with Financial Regulation  $7.03^{\frac{3}{2}}$ ; and
- (b) For a contribution or contributions towards the Agency's administrative expenses, in accordance with the principles for the assessment of Members for such contributions<sup>4/</sup>.
