REPORT ON CONTRIBUTIONS PLEDGED TO THE TECHNICAL CO-OPERATION FUND FOR 1998

1. By 9:00 p.m. on 1 October 1997, 35 Members of the Agency had pledged contributions to the Technical Co-operation Fund for 1998 as shown in the table in the annex.
