

Draft resolution submitted by Australia, Austria, Belgium, Bulgaria, Croatia, the Czech Republic, Denmark, Finland, France, Germany, Greece, Ireland, Italy, Luxembourg, the Netherlands, Norway, Poland, Portugal, Slovakia, Spain, Sweden, Switzerland, the United Kingdom of Great Britain and Northern Ireland and the United States of America

The General Conference,

- Recalling resolution GC(40)/RES/10, (a)
- Welcoming the entry into force of the Convention of Nuclear Safety on 24 October 1996.
- Welcoming the fact that 40 States have deposited their instruments of (c) ratification, acceptance or approval of the Convention,
- (d) Stressing the important role of the Agency in acting as a driving force in nuclear safety through its various safety programmes and initiatives,
- Noting that a preparatory meeting of Contracting Parties was held in Vienna from 21 to 24 April 1997 with the participation of 34 Contracting Parties,
- Recognizing that decisions on implementation of the Convention are the responsibility of States Parties,
- 1. Appeals to all States to sign and accede to the Convention;

- 2. <u>Expresses</u> its satisfaction that an organizational meeting will be held from 29 September to 2 October 1998 and that a first review meeting will begin on 12 April 1999; and
- 3. <u>Requests</u> the Secretariat to provide support, upon request, in accordance with Article 28 of the Convention.
