Amendment to Article VI of the Statute

Report by the Director General

- 1. On 1 October 1999, in resolution GC(43)/RES/19, the General Conference, at its 43^{rd} session, approved an amendment to Article VI of the Agency's Statute. As requested by the General Conference in the same resolution (operative paragraph 4), the Secretariat submitted a report on the progress made towards the entry into force of this amendment (GC(45)/INF/7) at the 45^{th} regular session of the General Conference. On 21 September 2001 the General Conference took note of the information contained in document GC(45)/INF/7 (GC(45)/OR.10, para 80).
- 2. On 14 August 2003, the Secretariat received a request, submitted by the Republic of Korea, for the inclusion of an item entitled "Amendment to Article VI of the Statute" in the agenda for the 47th regular session of the General Conference (Explanatory Memorandum Submitted by the Republic of Korea in Annex 1 to GC(47)/1/Add.1). The Secretariat has also been requested to submit an updated report on the progress made since the last report towards the entry into force of the amendment to the 47th regular session of the General Conference in order to facilitate discussion and proper action, if necessary, by the Member States.
- 3. The purpose of this document is to report to Members on the progress made towards the entry into force of the amendment since the last report (GC(45)/INF/7) submitted to the 45th regular session of the General Conference in 2001.

Progress Made towards Entry Into Force

4. On 26 September 2002, the Secretariat sent a circular note verbale to the Ministries of Foreign Affairs of Member States that referred in particular to the circular notes verbales sent by the Director General to the Ministers of Foreign Affairs of Member States dated 3 November 1999 and 10 November 2000 regarding the amendments to Article VI and paragraph A of Article XIV of the Statute of the IAEA that were approved by the General Conference on 1 October 1999 (for details of the latter notes verbales, please refer to paragraphs 2 and 3 of GC(45)/INF/7). It was indicated in the

note of 26 September 2002 that "[a]s regards the amendment to Article VI, its ultimate entry into force will result in the implementation of a carefully crafted and long sought solution to issues associated with representation of Member States on the Board of Governors" and that "the entry into force of [the amendments to Articles VI and XIV.A], through the deposit of instruments of acceptance by Member States with the Depositary Government (the United States of America), would be an important contribution to enhancing the effectiveness and efficiency of the Agency."

- 5. As of 22 August 2003, the Director General had been informed by the depositary Government that 34 Member States have accepted the amendment to Article VI in accordance with their respective constitutional processes.
- 6. Attached to this document as Annex 1 is a list of those States whose acceptance of the amendment has been notified by the depositary Government to the Agency as of 22 August 2003 (last change of status occurred on 17 July 2003).
