Fiftieth regular session Item 12 of the provisional agenda (GC(50)/1)

Amendment to Article XIV.A of the Statute

Report by the Director General

1. On 1 October 1999, in resolution GC(43)/RES/8 the General Conference, at its 43^{rd} session, approved an amendment to Article XIV.A of the Agency's Statute. In 2004 the Secretariat submitted document GC(48)/INF/8 to the General Conference at its 48^{th} session to inform Member States of progress in acceptance by Member States of the amendment and to reiterate the benefits of biennial budgeting.

2. By decision GC(49)/DEC/13 the General Conference "encourage[d] and urge[d] Member States that ha[d] not yet deposited instruments of acceptance of this amendment to do so as soon as feasible in order to allow the benefits of biennial budgeting to be attained".

3. In this connection the Agency's External Auditor recommended in his report on the audit of the Agency's accounts for 2004 that "efforts be made by Member States to complete the ratification process" for acceptance of the amendment (paragraph 109 of document GC(49)/7 refers). In his report on the audit of the Agency's accounts for 2005, the External Auditor repeated this recommendation (paragraph 89 of document GC(50)/8 refers)

4. The purpose of this document is to provide an updated report to Member States on the progress made.

Progress Made towards Entry into Force

5. In accordance with Article XVIII.C(ii) of the Statute, two-thirds of all Member States of the Agency have to accept the amendment in order for it to enter into force. Since the report to the last regular session of the General Conference, only one Member State has accepted the amendment, thereby bringing the number of Member States that have accepted the amendment to 39.

6. Attached as an Annex is a list of those States whose acceptance of the amendment has been notified by the depositary Government to the Agency as of the date of this document.
