Report on Contributions Pledged to the Technical Cooperation Fund for 2022

By 4.00 p.m. on Friday, 17 September 2021, 25 Members of the Agency had pledged contributions to the Technical Cooperation Fund (TCF) for 2022 as shown in the table in the Annex.

It is foreseen that the Conference will consider the matter of contributions pledged to the TCF in a plenary meeting at which the President will report on the contributions pledged by that time. A revision of the present document will be issued on Thursday, 23 September 2021 to keep the Conference informed of the pledges that Members are making, and a further revision will be issued after the close of the Conference.

Delegates who have not yet done so are invited to communicate their Governments' pledges as soon as possible to the officer who will be sitting during plenary meetings at the table marked "Financial Contributions" in the Plenary Hall in the M Building at the Vienna International Centre and who will at other times be in office M0E67 in the same building.
