Plenary 3rd meeting	Under agenda item 1 "Election of officers and appointment of the General Committee", the Conference elected Albania as an additional member of the General Committee.
	The Conference resumed consideration of item 6 of the agenda, "General debate and Annual Report for 2021". Statements were made by the Niger, Burkina Faso, Malaysia, Kuwait, Botswana, Viet Nam, Sudan, Qatar, Cuba, Chile, Lithuania, Belarus, the Bolivarian Republic of Venezuela, Türkiye, Indonesia, Kazakhstan, Latvia, Brazil, Costa Rica, Panama, Malta and the Republic of Korea.
Committee of the Whole 2nd meeting	Under agenda item 16 "Strengthening the Agency's activities related to nuclear science, technology and applications", the Committee agreed to recommend to the Conference for adoption the draft resolutions contained in documents GC(66)/COM.5/L.6, GC(66)/COM.5/L.7, GC(66)/COM.5/L.8, GC(66)/COM.5/L.9, GC(66)/COM.5/L.10, GC(66)/COM.5/L.11 and GC(66)/COM.5/L.12.
Plenary 4th meeting	The Conference resumed consideration of item 6 of the agenda, "General debate and Annual Report for 2021". Statements were made by Lesotho, Italy, Cyprus, Armenia, Pakistan, Monaco, Cambodia, the Lao People's Democratic Republic, South Africa, the Democratic Republic of the Congo, Zambia, China, Ireland, the United Arab Emirates, Ecuador, Mexico, Colombia, Romania, Kenya, Thailand, Iraq, Nicaragua, Spain, Australia, Singapore, Oman, El Salvador and the Syrian Arab Republic. Japan, the Republic of Korea and China exercised their right of reply.
