The Permanent Mission of the Russian Federation to the International Organizations in Vienna presents its compliments to the Secretariat of the International Atomic Energy Agency and has the honour to inform about the situation at the Zaporozhskaya NPP (ZNPP) as of 13 June 2023.

1. ZNPP operation and its safety and security.

During the period from 6 to 12 June, the ZNPP and the city of Energodar were not subject to fire impact of the armed forces of Ukraine (AFU).

During the period from 8 to 9 June, Ukraine conducted attacks against the open switchyard of the Zaporozhskaya thermal power plant with the usage of kamikaze drones.

Units №1, №3 are under planned repair; Units №2, №4 и №6 are in cold shutdown; Unit №5 is in hot shutdown.

The off-site power for the ZNPP own needs is supplied via 750 kV Dneprovskaya line.

Radiation background at the ZNPP site and beyond does not exceed the established standards.

Registration of employment contracts is going on. As of 9 June 2023, 3,540 employment contracts were signed, of which 380 – with operative personnel, 1,946 – with operational and maintenance personnel, 1,214 – with auxiliary and administrative personnel. The ZNPP has enough personnel to carry out the safe

operation of the plant in cold shutdown mode and for scheduled routine maintenance.

As of 09:00, 13 June, the water level in the Kakhovka reservoir after the destruction of the dam of the Kakhovskaya HPP is 11.19 m, the water level in the ZNPP cooling pond is 16.65 m.

2. Social issues.

Visiting hours for citizens were allocated in the administration of the city of Energodar, providing opportunity to address issues on housing and utilities.

The FMBA of Russia is organizing prophylactic medical examinations in the Zaporozhye region, including among the residents of the city of Energodar.

In the city of Energodar, street lighting, which had been damaged as a result of shelling by AFU, was restored.

The Permanent Mission of the Russian Federation requests the Secretariat to circulate this information among all IAEA Member States as soon as possible.
