Plenary 5th meeting

The Conference resumed consideration of **item 7** of the agenda, "General debate and Annual Report for 2023", and statements were made by the delegates of Finland, Georgia, Lao People's Democratic Republic, Peru, Spain, Ecuador, Romania, Guatemala, Bangladesh, Algeria, Chile, Nicaragua, Kuwait, Cyprus, Belarus, Tunisia, Paraguay, Oman, Mozambique, Malta, Greece, New Zealand and the United Arab Emirates.
